Resetting a device to its factory settings does not assure users that data has been permanently wiped. Instead, the Government needed a reliable and certified solution to ensure data could be permanently erased from any device across the country.

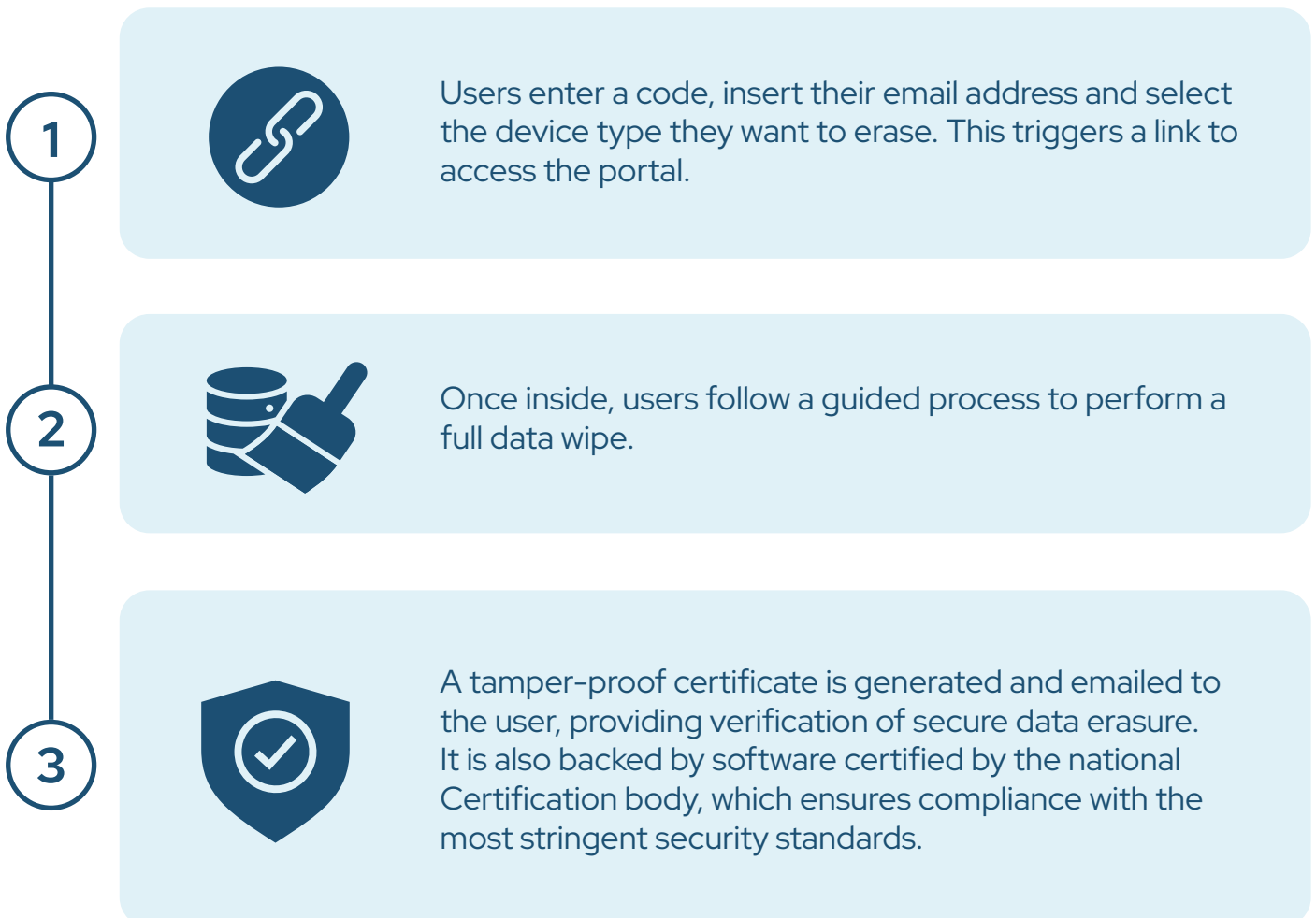


DELIVERING BENEFITS FOR ALL
